"Brief History of HUD Release Forms"

In conjunction with its implementation of the SWICA regulation, in April 1991 HUD issued a standard form, HUD Form 9886, which all applicants and tenants in HUD-assisted housing were required to sign. This form authorized HUD, PHAs and owners of assisted housing to collect certain personal information about tenants and applicants.¹ The form included a lengthy nonexclusive list of the categories of information that might be sought, including credit history, criminal activity, employment, marital status, and residences. The list of potential sources of information included schools and colleges, medical care providers and banks and financial institutions. The form provided that information could be gathered from any individual or organization without limitation, and did not limit it to confirmation of facts relevant to eligibility or rent recertification, nor did it contain an expiration date.

Tenants and applicants challenged the form as being unauthorized and in violation of statutory or constitutional limitations: the record-keeping requirements of the Privacy Act of 1974,² the restriction on governmental access to personal financial records of the Right to Financial Privacy Act,³ a separate statutory provision barring HUD from "imposing any unnecessarily duplicative or burdensome reporting requirements on tenants or Public Housing agencies ",⁴ and the constitutional right to privacy.

After litigation was filed challenging the original Form 9886,⁵ HUD revoked it and issued two new forms with a Notice directing that tenants not be evicted or have their assistance terminated for refusal to sign the old form. A revised Form 9886 covered public housing and

the Section 8 Certificate and Voucher programs, and a new Form 9887 covered the privately owned, multifamily subsidized projects.⁶

Congress also reacted to the controversy in 1992 by enacting a statute to require HUD to rewrite the form, after consulting with tenant organizations and their lawyers, and limiting it as to time and relevant material. The amendment prohibited the eviction of anyone for refusal to sign the old form.⁷ In 1993, Congress again amended the legislation to require tenants and applicants to sign a consent forms allowing HUD to collect certain kinds of income information from the Social Security Administration (SSA) and tax return information from the Internal Revenue Service (IRS).⁸ *See* discussion on HUD computer-matching with SSA and IRS in Chapter 3 of the Green Book, *infra*.
