Nasserghandi, 22 Number 93F 792-478. The trial was on August 27, 1993 before The Honorable Robert 23 Redding, judge of the above entitled court. Defendants Joe M. Westerman and Vicki L. 24 Westerman appeared through their attorney Sandra Saunders. Westermans are referred to as 25 "landlords" in this judgment. Defendant Douglas Bray did not appear. 1	through her attorney Frank Wall. Havana Nasserghandi is referred to as "tenant" in this
2	judgment.
3	The Court reviewed the District Court file and heard the argument of counsel
4	concerning paragraph 7a of the Petition for Writ of Review.
5	The Court concluded that 24 CFR 882.215(C)(4) requires a Section 8 landlord
6	to give the Housing Authority of Portland a copy of a termination notice, at the same time
7	notice is given to the tenant.
8	A landlord's failure to comply with 24 CFR 882.215(C)(4) is a defense in an
9	action for possession.
1()	The notice here was given to the tenant on July 8, 1993. The underlying FED
11	action was filed on July 12, 1992. A copy of the notice was faxed to the Housing Authority
12	on July 19, 1993 and the first appearance on the FED was July 20, 1993.
13	The notice was not given to the Housing Authority at the same time it was
14	given to the tenant. The landlord failed to comply with 24 CFR 882.215(C)(4).
15	The district court improperly construed the applicable law and its Judgment of
16	Restitution must be reversed.
17	NOW, THEREFORE, IT IS HEREBY ORDERED AND ADJUDGED:
18	1. The judgment of the district court in Westerman v. Nasserghandi, Number
19	93F 792-478 for restitution is reversed to grant possession to the tenant.
20	2. The funds tendered into court in Westerman v. Nasserghandi, Number 931
21	792-478 shall be released payable to defendants Joe M. Westerman and Vicki L. Westerman
22	for plaintiff Havana Nasserghandi's July 1993 rent.
23	3. The bond of \$100.00 which was posted in Nasserghandi v. Bray, et al,
24 25	Number 9308-05234 shall be released to plaintiff Havana Nasserghandi, payable to her
26	attorney, Frank Wall, 812 S.W. Washington #910, Portland, OR 97204.

1	4. Plaintiff Havana Nasserghandi is awarded costs and disbursements of
2	\$ 400 plus reasonable attorney fees of \$ 6 . Attorney fees shall
3	be paid to Plaintiff's attorney, Frank Wall, 812 S.W. Washington, Suite 910, Portland, OR
4	97205. This judgment may be amended to reflect reasonable attorney fees for postjudgment
5	collection.
6	5. Execution shall issue upon this judgment.
